**Did You Know that Carl Nunziato is Quite a Guy?

Student veterans at Youngstown State University (YSU) in Ohio have a state-of-the-art space on campus dedicated to serving their unique needs. The Carl A. Nunziato Veterans Resource Center, one of the few stand-alone buildings for student veterans in the nation, includes a lounge, televisions and video games, a community room, restrooms, computer labs, and a kitchenette stocked with donated snacks. It also offers VA counselors who can come to the center from Cleveland Veteran Center to meet with students.

It opened in September 2014 thanks to the efforts of several veteran alumni who led the campaign to raise \$1.4 million for the center’s creation. Among them, its namesake: Maj. Carl A. Nunziato, USA (Ret), a Life Member of MOAA and member of the [Mahoning and Shenango Valleys Chapter](#). In 2018, YSU renamed the center — originally called the Veterans Resource Center — in Nunziato’s honor.

Nunziato, a native of Youngstown who earned his commission as a second lieutenant through the YSU ROTC program, served two tours in Vietnam, during which he lost both of his legs after getting hit by a mortar during an enemy attack. He spent two years recovering at Walter Reed before earning his degree from Case Western Reserve University School of Law in Cleveland and then returning to his hometown where he worked for nearly 30 years in the banking industry.

Nunziato isn’t the only MOAA member who has had an integral role with the center.

Coast Guard CWO Don Oglesby was a charter member of Mahoning and Shenango Valleys Chapter when he passed away in March 2014. Oglesby had presented the MOAA medal to the YSU ROTC cadet since 2010. (Cont.)

Memorial donations in Oglesby’s honor that the chapter then matched were used to create the video game area for the center. Today, the chapter continues to upgrade the entertainment center as necessary, and many chapter members have made personal donations to the center and to a scholarship fund for veterans and currently serving military members.

The Carl A. Nunziato Veterans Resource Center is managed by chapter member Maj. Patrick “Rick” Williams, USA (Ret), who has served as associate director of the Office of Veterans Affairs at YSU since 2013. The center has made the services Williams’ office provides more visible to the student veteran population.

“Formerly, my office was tucked away on the top floor of an administrative building, and nobody knew where I was,” he said. “When the Veterans Resource Center opened on campus, I moved into a 6,000-square-foot, two-story building dedicated to the success of our roughly 350 military-connected student population.”

Williams, who served 26 years in the Army and was a military science professor at YSU, said the center helps current and prior military members and eligible dependents achieve their academic goals and navigate their education benefits.

“While we can’t take care of every aspect of the college experience, we try to project ourselves as a ‘one-stop shop’ for veterans,” he said. “The majority of veterans on campus would tell you they love having a place on campus to get all their answers to veteran-related issues.”

**Did You Know 2? MOAA Seeks Legislative Fix for ‘Dreamers’ That Allows a Path to Citizenship Through Service**

MOAA joined with several other military service and immigrant advocacy organizations in a recent letter to Capitol Hill leaders asking for permanent legislative solutions to the Deferred Action for Childhood Arrivals (DACA) program as it pertains to servicemembers and their families.

The Supreme Court recently issued a [ruling](#) to preserve the DACA program. DACA provides protections for individuals commonly known as “Dreamers” -- undocumented immigrants who arrive in the U.S. as children. The program allows them to apply for [deferred action](#) and a work permit if they do not have a serious criminal record. So, what does this mean for servicemembers and their families?

There are approximately 800 DACA recipients serving in the U.S. military through the Military Accessions Vital to National Interests (MAVNI) program. Immigrant servicemembers contribute critical skills that make our military effective, including language translation and medical services.

As the military services struggle with [recruitment and retention](#), it is important to keep these contributions in mind. [A 2017 study](#) from the Migration Policy Institute estimates approximately 71,000 (Cont.)

dreamers could use military service as a path to citizenship if legislative solutions were put in place.

In the letter, MOAA and other military and immigrant advocacy groups ask House and Senate leaders to:

- Create a permanent legislative solution allowing Dreamers to obtain lawful permanent status. This would create a path to permanent citizenship through military service
- Ensure the 800 DACA recipients now serving in the military can continue to serve.
- Guarantee DACA recipients who have served or are currently serving be granted access to earned benefits including health care, transitional programs, and [Parole in Place](#), and are encouraged to take advantage of the existing fast track to citizenship.

In 2019, MOAA also submitted [a statement for the record](#) highlighting this issue and others that impact immigrant servicemembers, veterans, and their families.

### Did You Know 3? Veterans Community Unites Around NDAA Amendment to Cover Additional Agent Orange Presumptives—Cory Titus, MOAA National

A bipartisan amendment to the House version of the FY 2021 National Defense Authorization Act (NDAA) would match last week's [Senate NDAA amendment](#) and provide more good news for Vietnam veterans suffering from bladder cancer, hypothyroidism, and Parkinson's-like symptoms.

House Amendment 264, introduced by Rep. Josh Harder (D-Calif.), would add these conditions, which have been scientifically linked to Agent Orange exposure, to [the list of Agent Orange presumptives](#). The amendment echoes S.A. 1972, which was introduced by Sen. Jon Tester (D-Mont.) last week.

#### [TAKE ACTION: [Call](#) or [Write](#) Your Lawmaker Today to Support Vietnam Veterans]

Following the news from the Senate, the veterans' community came together quickly to show its support. Within a week of the announcement, MOAA joined with 32 organizations to send letters to [Senate](#) and [House](#) leaders asking for their support for the care and compensation of veterans affected by Agent Orange. Gold Star Wives of America and the Tragedy Assistance Program for Survivors shared support independently, adding to the list of organizations behind the measure.

"I'm heartened to see that Congress is not forgetting our Vietnam veterans," MOAA President and CEO Lt. Gen. Dana T. Atkins, USAF (Ret), said. "As a nation, we must ensure all our veterans are taken care of when they experience negative health consequences like toxic exposures from their service. When illnesses like bladder cancer, hypothyroidism, and Parkinson's-like symptoms meet the scientific standards to be connected with Agent Orange, we must add them to the list of presumptives. "Tens of thousands of veterans are suffering from these illnesses," Atkins said.. "Congress can care for (Cont.)

for them by providing the benefits and compensation they deserve. I urge Congress to include Sen. Tester's and Rep. Harder's amendments and pass them in this year's NDAA."

While 35 organizations are backing the measure, showing a high level of support, there are still challenges ahead with passing these amendments. The cost of providing these benefits has held up this issue to date; the VA has the authority to add these diseases to the presumptive list unilaterally, but without the funding, VA officials indicate they will have to make hard choices in cutting benefits to veterans in other areas. It remains uncertain this will be VA's position should Congress approve what could be the agency's [biggest budget ever](#).

This is where members of Congress need to hear your support on this issue. The House amendment will be considered by the House Rules Committee before making it to the floor, which is expected to happen this week. The Senate amendment will receive a formal vote next week. Many members are still learning about this issue and considering their votes for amendments, so now is the time to [call](#) or [write to](#) your lawmakers.

### Did You Know 4? VA Gets Boost in Emergency Funding for Community Care in 2021—contributed by CDR René Campos, USN (Ret), Senior Director of Government Relations, MOAA National

In an unusual maneuver July 9, the House Appropriations Committee approved by a vote of 30-20 its fiscal year 2021 funding package for DoD military personnel and construction projects and VA health care and benefits programs, designating \$12.5 billion in emergency funding to avoid budget cap restrictions imposed in last year's budget agreement to ensure adequate resources for veterans health care in the community.

The VA and lawmakers have been wrestling with the rapidly growing costs of veterans' health care in recent years. These increases are due in part to the passage of the [VA MISSION Act](#) in 2018 to address the long waiting lists for veterans seeking care in VA at the time. The FY 2021 funding boost in large part is to provide more funding for VA community care, which was expanded in the act. "We have finally achieved consensus with the Senate that the cost of VA health care is growing exponentially and cannot remain within the budget caps," said Rep. Debbie Wasserman Schultz (D-Fla.), chair of the House Appropriations Subcommittee on Military Construction, Veterans Affairs, and Related Agencies. "For that reason, the \$12.5 billion within the total is designated as emergency funding to adequately fund VA health care."

The \$104.8 billion discretionary funding in the House bill for VA is \$12.3 billion above this year's spending levels but is \$35 million below the president's budget request. \$90 billion of the discretionary funding is for VA health care — in line with the president's request but \$9.8 billion (Cont.)

above FY 2020 authorization.

Some of the VA provisions include:

- \$10.3 billion for mental health care and \$313 million for suicide prevention outreach.
- \$661 million in gender-specific care for women.
- \$1.9 billion for VA homeless assistance programs.
- \$504 million for opioid abuse prevention programs.
- \$300 million for rural health initiatives.
- Increase funding in medical and prosthetic research, implementation of VA's electronic health record system, and VA construction projects.
- \$3.2 billion for VA Benefits Administration operations to include processing of disability claims and appeals backlogs — \$62 million more than FY 2020.
- \$94.2 billion for advance FY 2022 funding for VA medical programs, and \$145.3 billion in advance mandatory funding for VA benefit programs to ensure continuity in veterans' health care and benefits in the event of continuing resolution or disruption to the funding.

House Appropriations Committee Chair Rep. Nita Lowey (D-N.Y.) stated, "This bill makes unprecedented investments in our veterans through our VA medical system to ensure that every veteran has access to the top-notch health care they deserve."

MOAA is grateful for House appropriators making VA's budget a top priority again this year and for lawmakers' understanding of how important this funding is for our veterans. It is especially critical during this time as the country continues waging war against COVID-19.

The bill will now go to the full House for a vote. We urge the House and the Senate to move quickly in passing the VA appropriations bill and the 11 other government spending bills so funding for VA and all federal agencies will be in place when the new fiscal year begins Oct. 1.

## SURVIVING SPOUSE CORNER

### Craig Smith, Surviving Spouse/Personal Affairs Chair

I wanted to expand on last month's article concerning SBP/DIC elimination and If these changes affect remarriage.

There has been some confusion by the amount of frequently asked questions on the DFAS website.

**BOTTOM LINE:** There is no change regarding the age and eligibility with remarriage and it effects on SBP or DIC, which continue to be in effect at this time. Section 622 of the National Defense Authorization Act for Fiscal Year 2020, provides all of these details. Some Surviving Spouses only receive DIC and will continue to receive their portion. If SBP was declined at retirement, it was an irrevocable decision; there is no redo or open season to apply. Special Survivor Indemnity Allowance (SSIA) is an SBP benefit that was a supplement for the DIC offset. This benefit is eliminated when the SBP/ DIC offset is completely eliminated 1 January 2023. DFAS has indicated these changes will automatically take place.
