

"Notice of Proposed Revision of Chapter Bylaws"

March 29, 2024

All chapter members are hereby given notice of the proposed revision of the chapter bylaws. The below (updated) executive summary is provided for your reference:

See item 8 below for a description of the portion of the proposed bylaws revision updated from the version previously sent out to the membership.

"Executive Summary of The Proposed Chapter Bylaws Revision"

- 1) The changes made in this proposed Chapter Bylaws are sufficient to constitute a revision of the current bylaws.
- 2) Other than the below specific changes most other changes in this revision of the chapter bylaws are editorial/typographical in nature and do not change the intent of any articles/sections affected.
- 3) The bylaws were changed to reflect the addition of the United States Space Force (USSF) as one of the recognized uniformed services of the United States of America in each article/section where appropriate.
- 4) Wording was changed in each article/section where appropriate to address both military members and surviving spouse members as "regular members" of the chapter.
- 5) The position of "Surviving Spouse Liaison" was added to the list of elected officer positions for the chapter.
- 6) Wording was changed in each article/section where appropriate to designate all elected officer positions, with the exception of chapter President, 1st Vice President & 2nd Vice President, as positions that can be filled by a spouse of a regular chapter member if there is no regular member available to fill the elected officer position.
- 7) The normal date for the monthly chapter board of directors (BOD) meeting was changed to the second Wednesday of each month.
- 8) The duties of the surviving spouse liaison have been added to article IX and the duties of the other elected officers have been put into bullet format to make them easier to understand.

The proposed revisions and update of the chapter bylaws has been approved by the board of directors and will be presented to the general membership at the April 17 luncheon meeting for ratification of the same by the general membership.

I'm reminded of a quote by Henri Bergman, writing in *Creative Evolution*, which says this about change in our lives, "To exist is to change, to change is to mature, to mature is to go on creating oneself endlessly."

Spring is a time we change from winter thoughts and practices to sunshiny days and warmer temperatures, spring showers, and dreams of summer at the beach. Spring is a time to embrace new ideas, new sources of enlightenment. April is the 4<sup>th</sup> month of the year. #### Captain Patrick J. Mayhew, SC, USNR (Ret), passed away on February 23, 2024.

Born in Jacksonville, Florida, Pat grew up on Lakeshore Boulevard. He graduated from Bishop Kenny High School, then from Georgetown University's Walsh School of Foreign Service. Coming of age during the Vietnam War, he entered the Navy in 1969 served as an officer in the Naval Supply Corps until he retired from the Naval Reserve as a Captain in 1994.

Pat and Helene were married at Pat's childhood church, St. Matthew's Catholic Church, on August 1, 1987.

In civilian life Pat worked at Prudential, Ryder-PIE and CSX primarily in Internal Audit and payroll. He served on the board of the Omni Federal Credit Union and Harbor House Group Homes for Developmentally Disabled Adults. He was chairman of the board when Harbor House applied for and became a member of the L'Arche worldwide community. His funeral Mass was held at St. John Paul II Catholic Church on March 14, 2024, and he was interred at the Jacksonville National Cemetery.

#### Military Health System Reform Oversight — A MOAA Advocacy in Action Success Story

If you tried to fill a prescription at the Naval Station Jacksonville Pharmacy in the last couple of years, you might have noticed that service was slower than many of us remember—even for active duty patrons. This article from the MOAA *Advocacy in Action* site testifies to the success of our organization in effecting change.

As part of the FY 2017 NDAA military health system (MHS) reform legislation, Congress directed DoD to restructure the direct care system of military hospitals and clinics to improve focus on military medical readiness. This led to a February 2020 DoD report to Congress outlining plans to downsize dozens of military treatment facilities (MTFs). It came on the heels of a separate proposal in the DoD budget request to cut 18,000 medical staff to realign resources in support of the National Defense Strategy. With hundreds of thousands of beneficiaries potentially affected by these changes, MOAA immediately pressed DoD officials for the statistics and analysis behind these moves, and asked Congress to exercise its oversight authority and ensure continued access to quality care. Media outlets amplified MOAA's messages of concern.

These messages grew louder as both the military and civilian medical systems began buckling under the strain of COVID-19. MOAA <u>led the charge</u> to ensure continued access to quality care as MHS reforms are implemented. With the FY 2020, 2021 and 2022 NDAA laws, MOAA has achieved three consecutive halts to planned medical billet cuts along with enhanced congressional oversight to MHS reforms, including:

A DoD <u>report to Congress</u> on analysis, metrics, and mitigation planning related to proposed billet cuts – <u>Section 719</u>, FY 2020 NDAA.

- A DoD review of the medical manpower requirements for all national defense strategy scenarios, including with respect to the homeland defense mission and pandemic influenza <u>Section 717 FY 2021 NDAA</u>.
- A DoD requirement to certify to the congressional defense committees that beneficiaries impacted by MTF restructuring will have access to civilian care through the TRICARE program Section 718 FY 2021 NDAA.
- A GAO evaluation of the DoD analyses used to support any reduction or realignment of military medical manning and a compliance report that requires DoD to explain any reductions in MTF staffing Section 731 FY 2022 NDAA.

The passage of the FY 2023 NDAA marks the <u>fourth consecutive MOAA "win"</u> on this issue. Provisions in this act require a series of reports and congressional notification before DoD makes any similar plans to cut personnel at its military treatment facilities (MTFs) and include:

- Congressional notification before modifying the scope of services provided at MTFs.
- Extensive reporting requirements on medical workforce requirements, including risk analysis and mitigation plans.
- A five-year halt to medical billet cuts.
- A one-year suspension on MTF restructuring.
- Reporting on the composition of medical personnel of each military department, including vacancies and a validation against military requirements.

The FY 2023 NDAA also extends the timeframe for a Government Accountability Office report mandated by the previous year's NDAA to evaluate DoD's plans to reduce military medical manning.

This issue also impacts Families, Retirees, and Survivors. It is one of many where we can have a positive impact by letting our Representatives and Senators know how important medical services are to sustaining readiness, quality of life and the perceptions that affect recruiting and retention of personnel.
