## March Program

**Brigadier General STEPHEN P. SNELSON**

Brig. Gen. Stephen P. Snelson serves as the Deputy Director of Operations, U.S. Central Command. In his current role, he is responsible for developing contingency plans and assisting the Director of Operations and the Commander with overseeing joint operations across a 21-Nation area of responsibility, including the Middle East, Central and South Asia, and the strategic waterways surrounding them.



Brig. Gen. Snelson was commissioned in 1997 as a Distinguished Graduate of the Reserve Officer Training Corps program at Syracuse University, Syracuse, New York. He commanded at multiple echelons, including the 305th Operations Support Squadron, was the Vice Commander, 62nd Airlift Wing at Joint Base Lewis-McChord, Washington, commanded the 6th

Air Refueling Wing at MacDill Air Force Base, Florida, and commanded the 89th Airlift Wing at JB Andrews, Maryland, where he was responsible for worldwide special air missions providing airlift for the President, Vice President, cabinet members, combatant commanders, and other senior military and elected leaders. He has flown operational missions worldwide, including combat missions supporting operations Allied Force, Southern Watch, Enduring Freedom, Iraqi Freedom, and New Dawn.

Brigadier General Snelson will brief the group on March 1, 2023, on how Air Power fits in with contingency planning. He will outline current weapons platforms' capabilities, including the inception and employment of the U.S. Space Force.

Her business model went from assembling items in her garage and attending local craft fairs to managing 45 employees in Florida and 35 "remote riveters" all over the nation. She encourages you to stay flexible as you begin any career or entrepreneurial journey.

Choose courage over staying comfortable when you're starting a new professional path. Be willing to try something new to see where it gets you and love what you are doing – otherwise, Cruse said, whatever you're doing won't feel like it is enough.

The goal for Cruse was never simply handbags – it was about making a positive impact, providing military spouses with an inspiration, and empowering our community to be the best it can be.

## Filing and Keeping Your Homestead Exemption

When a person serving in the Armed Forces owns and uses property as a homestead, the servicemember may rent the homestead property without abandoning the claim to the homestead exemption (see section 196.061, Florida Statutes).

A servicemember's next of kin or any other person who has written authorization may file a homestead exemption claim on behalf of a servicemember who cannot file in person because of a service obligation (see s. 196.071, F.S.).

## Property Tax Exemptions and Discounts

Eligibility for property tax exemptions depends on satisfying certain requirements.

Information is available from the property appraiser's office in the county where the veteran or surviving spouse owns a homestead or other property.

- An ex-servicemember who was honorably discharged, is a resident of Florida, and who is disabled to a degree of 10% or more because of misfortune or while serving during wartime may be entitled to a \$5,000 reduction in his or her property's assessed value. This exemption is not limited to homestead property. Under certain circumstances, the veteran's surviving spouse may be entitled to carry over the exemption. See Form [DR-501](#). (see s. 196.24, F.S.)
- Veterans who are Florida residents and were honorably discharged with a service-related total and permanent disability may be eligible for a total exemption from ad valorem taxes on property they own and use as their homesteads. A similar exemption is available to disabled veterans confined to wheelchairs. Under certain circumstances, the veteran's surviving spouse may be entitled to carry over the exemption. See Form [DR-501](#). (see ss. 196.081 and 196.091, F.S.)
- If they meet certain requirements, veterans 65 or older who are partially or totally permanently disabled may receive a discount on the assessed value of property that they own and use as homesteads. This discount carries over to the veteran's surviving spouse if the spouse holds the legal or beneficial title to the homestead, permanently resides there and has not remarried. The discount is a percentage equal to the percentage of the veteran's permanent, service-connected disability as determined by the United States Department of Veteran's Affairs. See Form [DR-501](#). (see s. 196.082, F.S.)



Eligible veterans who want to apply for these exemptions may apply before they receive the necessary documentation from the United States government or the United States Department of Veterans Affairs or its predecessor. After the property appraiser receives the documentation, the exemption will be effective as of the date of the original application. Please see the [How to Apply for a Refund](#) brochure for information about refunds.

- A member or former member of any branch of the United States military or military reserves, the United States Coast Guard or its reserves, or the Florida National Guard may receive an exemption if he or she was deployed during the previous calendar year outside the continental United States, Alaska, and Hawaii in support of a designated operation (the Florida Legislature designates operations for this exemption). The percent of the taxable value that is exempt for the current year corresponds to the percent of time during the previous year when the service member was deployed on a designated operation. See Form [DR-501M](#). (see s. 196.173, F.S.)

You should file all required forms and applications for these exemptions with your county property appraiser. If the property appraiser denies your application, you may file a petition with the county's value adjustment board. For more information, see [Petitions to the Value Adjustment Board](#).



# Legislative Liaison Corner

## March Update

This edition's update centers on upcoming legislation in consideration as provided by the Florida Department of Veterans' Affairs (FDVA) found at <https://www.floridavets.org/news/veteran-legislation/>.

The 2023 Florida Legislative Session is scheduled to begin March 7 and conclude May 5. Preparatory interim committee meetings took place: January 23-27, February 6-10, 13-17, and 20-24.

#### **House Bill (HB) 0139 by Marie Paule Woodson, Democrat, District 105 consisting of parts of Broward and Miami-Dade Counties**

Benefits, Training, and Employment for Veterans and Their Spouses: Requires analysis of VETS Program; revises duties of DVA & Florida Is For Veterans, Inc., to include assistance to veterans' spouses; requires DVA to create grant program for veterans' nursing degree programs; revises purpose & duties of VETS Program to include assistance to veterans' spouses & apply solely to target industry & supplemental industry businesses; requires Florida Is For Veterans, Inc., to assist veterans or their spouses in accessing employment in health care professions; requires appropriate board or DOH to expedite health care licensure applications submitted by veterans; establishes Office of Veteran Licensure Services; provides duties; requires report to Governor & Legislature. Effective Date: July 1, 2023

#### **Senate Bill (SB) 0274 by Bryan Avila, Republican, District 39 consisting of part of Miami-Dade County**

Nursing Education Pathway for Military Combat Medics; Revising a primary goal of the Florida Center for Nursing to provide that development of a statewide plan for nursing manpower must include the encouragement and coordination of the development of partnerships with hospitals which provide opportunities for nursing students to obtain clinical experience; requiring that the Articulation Coordinating Committee convene a workgroup to establish a process for determining postsecondary course equivalencies and the minimum postsecondary credit or career education clock hours that must be awarded in accredited nursing education programs for military training and education required for service in specified positions; authorizing the award of additional postsecondary credit or career education clock hours, etc. Effective Date: Upon becoming a law.

#### **HB 0339 by Taylor Michael Yakorsky, Republican, District 25 consisting of part of Lake County**

Education of Dependents of Deceased or Disabled Servicemembers, Prisoners of War, and Persons Missing in Action: Revises eligibility requirements for educational benefits provided by state to spouse or dependent child of deceased or disabled servicemember; revises eligibility requirements for educational benefits provided by state to dependent child of prisoner of war, person missing in action, or deceased or disabled servicemember who participated in certain military operations. Effective Date: July 1, 2023

**SB 0366 by Danny Burgess, Republican, District 23 consisting of parts of Hillsborough and Pasco Counties**

Dental Services for Veterans; Establishing the Veterans Dental Care Grant Program in the Department of Veterans' Affairs; requiring the department to contract with a direct-service organization to administer the program, etc. Effective Date: July 1, 2023

**SB 0386 by Jennifer Bradley, Republican, District 6 consisting of Baker, Bradford, Clay, Columbia, Gilchrist, Union Counties and part of Alachua County**

Specialty License Plates/United Service Organizations; Directing the Department of Highway Safety and Motor Vehicles to develop a United Service Organizations license plate; providing for distribution of fees collected from the sale of the plate, etc. Effective Date: October 1, 2023

**HB 0417 by John Paul Temple, Republican, District 52 consisting of Sumter County and part of Hernando County**

State Lottery Funding for Veterans' Assistance Education Programs: Requires Department of Lottery to create instant-ticket lottery game that benefits veterans' assistance education programs; provides that veterans' assistance education programs may be funded by Educational Enhancement Trust Fund; requires department to provide certain information to public. Effective Date: July 1, 2023

**HB 0453 by Lisa Dunkley, Democrat, District 97 consisting of part of Broward County**

Veterans' Assistance Grants: Requires DVA, subject to appropriation, to award grants to certain entities for purpose of increasing public awareness of benefits & services available to veterans; provides requirements for initial grant recipients; requires report to DVA as condition for consideration for subsequent grants; requires DVA to adopt rules. Effective Date: July 1, 2023

**HB 0485 by Michelle Salzman, Republican, District 1 consisting of part of Escambia County**

Veterans' Services and Recognition: Creates Division of Long-term Care; revises qualifications for county & city veteran service officers; creates "Veterans' Adult Day Health Care of Florida Act"; provides purpose & definitions; provides for appointment, qualifications, duties, & responsibilities of program operator; establishes nondiscrimination policy; provides program admittance eligibility & priority; provides for audits, inspections, & operational standards; designates "Veterans Week." Effective Date: July 1, 2023

**SB 0502 by Darryl Ervin Rouson, Democrat, District 16 consisting of parts of Hillsborough, Pinellas Counties**

Public Records/Veterans Treatment Court Programs; Providing an exemption from public records requirements for certain information of persons participating in, or considered for participation in, veterans treatment court programs; authorizing the disclosure of confidential and exempt information under certain circumstances; providing for legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: Upon becoming a law.

**HB 0517 by Dr Joel Rudman, Republican, District 3 consisting of parts of Okaloosa and Santa Rosa Counties**

Nursing Education for Military Combat Medics: Revising a primary goal of the Florida Center for Nursing to provide that development of a statewide plan for nursing manpower must include the encouragement and coordination of the development of partnerships with hospitals which provide opportunities for nursing students to obtain clinical experience; requiring that the Articulation Coordinating Committee convene a workgroup to establish a process for determining postsecondary course equivalencies and the minimum postsecondary credit or career education clock hours that must be awarded in accredited nursing education programs for military training and education required for service in specified positions; authorizing the award of additional postsecondary credit or career education clock hours. Effective Date: upon becoming a law.

**SB 0550 by Danny Burgess, Republican, District 23 consisting of parts of Hillsborough and Pasco Counties**

Education of Dependents of Deceased or Disabled Servicemembers, Prisoners of War, and Persons Missing in Action; Defining the term "servicemember"; revising eligibility requirements for educational benefits provided by the state to a spouse or dependent child of a deceased or disabled servicemember; revising eligibility requirements for educational benefits provided by the state to a dependent child of a prisoner of war or a person missing in action; revising eligibility requirements for educational benefits provided by the state to a dependent child of a deceased or disabled servicemember who participated in certain military operations, etc. Effective Date: July 1, 2023

**SB 0632 by Bobby Powell, Democrat, District 24 consisting of part of Palm Beach County**

Veterans' Preference in Promotion; Requiring the state and its political subdivisions to give preference in promotion in positions of employment to certain veterans or their relatives; requiring the Department of Veterans' Affairs to adopt certain rules to ensure veterans are given special consideration in the promotion process; requiring a numerically based selection process to be used to determine qualifications for promotion; providing for an investigation and administrative hearing of a complaint regarding not being awarded a promotion according to veterans' promotion preference, etc. Effective Date: July 1, 2023

**HB 0635 by Patt Maney, Republican, District 4 consisting of part of Okaloosa County**

Dental Services for Veterans: Establishes Veterans Dental Care Grant Program in Department of Veterans' Affairs; specifies purpose of program; requires department to contract with direct-service organization to administer program; requires department to adopt rules; provides that program funding is subject to legislative appropriation. Effective Date: July 1, 2023

**HB 0687 by Kimberly Daniels, Democrat, District 14 consisting of part of Duval County**

Veterans' Preference for Promotion: Requires state & political subdivisions to give veterans' preference in employment promotion; authorizes waiver of postsecondary educational requirements; requires DVA to adopt rules to ensure veterans' preference in promotion; requires numerically based selection process to be used to determine qualifications for promotion; requires preference in promotion in positions for which numerically based selection process is not used; provides for investigation & administrative hearing of complaint regarding veterans' promotion preference; provides that military retirement on basis of longevity does not disqualify person from veterans' promotion preference. Effective Date: July 1, 2023
