The first step in contacting our members of Congress is knowing who they are. You can write them by simply addressing a letter as follows, being sure it has a return address:

Obtaining phone numbers and local (home town) office addresses is as simple as typing www.house.gov or www.senate.gov and searching for your representative's name.

MOAA national's website (www.moaa.org) makes it easy for members to learn about issues and contact their elected officials. Here's how you do it:

- 1—Find your MOAA membership number (one place to look is on the mailing level of Military Officer that you get every month or on your membership card. You will need it to create an account.
- 2—Go to www.MOAA.org and log in. If you have never done it, you can easily set up an account using your e-mail address and a password you create.
- 3-Once you are in the site, click on the "ADVOCACY' button, then click on the "Legislative Action" button. There will be a form to fill out, but once you do it, the site will remember you when you come back, and it will remember your legislators, too.
- 4—Clicking those buttons will take you to <a href="https://moaa.quorum.us/">https://moaa.quorum.us/</a>, where you can select an issue you want to contact your elected officials about, and you will be able to read about it and edit a pre-written letter to that Member of Congress. You can also write your own letter if you like.
